Foundation governors shall be appointed as follows:

- (a) 3 appointed by the Lichfield Diocesan Board of Education,
- (b) 4 appointed by the District Church Council of the Church of Shelton St. Mark's.
- (a) The holder of the following office shall be an ex-officio foundation governor:

The Principal Officiating Minister of the Parish of Hanley The Holy Evangelists.

(b) The foundation body or person named in paragraph 8 shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (a) above, in the event that the ex-officio foundation governor is unable or unwilling to act as a foundation governor or has been removed from office under regulation 21 (2) of the Constitution Regulations.

The Archdeacon of Stoke-upon-Trent is entitled to request the removal of the ex-officio foundation governor and to appoint any substitute governor.

St Mark's CE(A) Primary school was established as a church school by an Indenture of the 6th April 1838 between John Yates and William Yates of the first part and John Thomlinson, William Taylor Copeland, William Bishop, John Hales and James Ralphs of the second part. The Rector and Churchwardens of the Parish of Hanley the Holy Evangelists are trustees of the school.

St Mark's CE Primary School Ethos Statement:
